## Privacy

**Thank you for visiting this Website. Please read these Terms and Conditions ("Terms") carefully before using this Site.**

These Terms describe Our policies and procedures on the collection, use and disclosure of Your information when You use the Website and tells You about Your privacy rights and how the law protects You.

We use Your Personal data to provide and improve the Site. By using the Website, You agree to the collection and use of information in accordance with these Terms.

For the purposes of these Terms:

- “*You or Your*”: means the individual accessing or using the website and related services.
- “*We, Our or Us*”: means LEO wildlife and conservation volunteers, Hoopdal 96 KQ Rooiberg Road, Thabazimbi, South Africa.
- “*Website or Site*”: refers to LEOAFRICA, accessible from [www.leoafrika.org](http://www.leoafrika.org)
- “*Service*”: refers to the LEOAFRICA Website.
- “*Third-party Social Media Service*”: refers to any website or any social network website through which a User can log in or create an account to use the Service.
- “*Personal Data*”: is any information that relates to an identified or identifiable individual.
- “*Cookies*”: are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website.
- “*Device*”: means any device that can access the Service such as a computer, a cell phone or a digital tablet.

#### Usage Data

Usage Data is collected automatically when using the Service.

- *Functionality Cookies*  
Type: Persistent Cookies  
Administered by: Us  
Purpose: These Cookies allow us to remember choices You make when You use the Website, such as remembering Your login details or language preference. The purpose of these Cookies is to provide You with a more personal experience and to avoid You having to re-enter Your preferences every time You use the Website.
